Category 'A' -

For students who have already enrolled in the old National Web Portal (www.mhrdnats.gov.in) (NATS 1.0) and having login credentials

Step 1:

- b. Click Student
- c. Click Student login
- d. Click Forgot Password
- e. Enter registered email id to get activation link & Reset password.

Step 2:

- a. Student login
- b. Enter registered email id & new password
- c. Complete application form
- d. A unique Enrollment number (12/16 digits) for each student will be generated.

After completion of enrollment (new portal migration)

For applying

- a. Login with email id with new password
- b. Under "Apply against advertised vacancies" search "Translational Health Science & Technology Institute (THSTI)"
- c. Click apply (Once successfully applied, the status can be seen as "Applied".

Category 'B' -

For students who have already enrolled in the new National Web Portal

PLEASE NOTE (FOR ALL THE CATEGORIES-A, B & C):

2. Uploading the required documents, including a photograph, Aadhaar card, bank passbook, and degree/diploma educational certificates (degree certificate, provisional certificate, or consolidated mark sheet), as well as mentioning the percentage of marks obtained in graduation/diploma, is mandatory. Candidates are advised to ensure they enter the percentage of marks in the field '% of marks /CGPA on the NATS portal. Failure to provide the percentage of marks will result in the rejection of their candidature.

D TERMS AND CONDITIONS

- I. Candidates who have successfully passed the qualifying exam (Graduation/Diploma) within the last five years and secured minimum 55% marks will only be considered. In Case of Universities/Institutes awarding CGPA grading, should have CGPA 6 and above.
- II. The candidate who have already undergone or are currently undergoing apprenticeship training under Apprenticeship Act 1961, and/or having one-year work experience are not eligible to apply.
- III. The candidate shall have standard of fitness as prescribed in the clause 4/Schedule II of apprenticeship rules 1992, and amendments thereof, if any.
- IV. Guidelines under Apprentices Act on Reservation for SC/ST/OBC will be adhered to. Those who are claiming reservation under SC/ST/OBC shall provide certificate as per Government of India standard format.
- V. The institute reserves the right to adopt its own method of short-listing criteria and is not obliged to shortlist all candidates who fulfil the minimum requirement.
- VI. No correspondence or enquiries will be entertained from the candidates related to the engagement.
- VII. Any amendment/updates and list of selected candidates will only be uploaded on our website. Candidates are advised to visit the website for the same regularly.
- VIII. Canvassing in any form will be treated as a disqualification.
 - IX. Incomplete application will be summarily rejected. The Institute will not be responsible for any application being rejected or candidate not shortlisted due to incorrect information submitted by the candidate.
