Sub: Conversion of mode of stipend from reimbursement to DBT for all apprentices from the month of November, 2025 onwards.

All the establishment fraternity registered under NATS and hiring / intened to hire apprentice are hereby informed that Government of India as per its policy of conversion of mode of payment of Central Government share of stipend from reimbursement to DBT mode has decided to move forward and go for 100% transition on payment of stipend from reimbursement to DBT mode from the month of November, 2025 onwards.

Accordingly, all training establishments to ensure that the payment of stipend to the apprentices from the month of November, 2025 onwards must be done only through DBT mode. No reimbursement will be applicable for the stipend payable from 01.11.2025 onwards. All concerned establishment must take appropriate action at their level to ensure this transition of mode of payment of stipend and ensure to raise the DBT request for payment of stipend apprentices for the month of November, 2025 payable from 01.12.2025 onwards through NATS portal. The DBT mode of stipend payment shall be raised through ROP in the concurrent month without delay, e.g, the establishment raising ROP for DBT mode of payment to the apprentices for the month of November, 2025 within the month of December, 2025.
