



## 2. Eligibility:

**For Technician (Diploma) Apprentices:** Candidates should have passed Diploma in Engineering/ Technology from State Board of Technical Education as mentioned at 1(a) and the gap between the date of contract after joining apprenticeship and the date of passing the qualification should not be more than 5 years.

**For Graduate Apprentices in General Stream:** Candidates should have successfully completed Degree from a recognized university as mentioned at 1(b) and the gap between the date of contract after joining apprenticeship and the date of passing the qualification should not be more than 5 years.

**For Engineering Graduate Apprentices:** Candidates should have successfully completed Degree in Engineering/ Technology from a recognized university as mentioned at 1(c) and the gap between the date of contract after joining apprenticeship and the date of passing the qualification should not be more than 5 years.

## 3. Reservations:

The reservations for engagement of Apprentices shall be applicable for EWS, OBC, SC, ST, PH Candidates, Ex-Servicemen as per the Apprentices Act 1961 & Rules and Subsequent amendments and for wards of HAL as per HAL Corporate Office Guidelines.

## 4. Stipend:

The Stipend shall be paid monthly as per the Apprentices Act 1961 & Rules and Subsequent amendments.

## 5. How to Apply:

Interested and eligible candidates who meet the notified criteria may Walk-in as per the given details and procedure mentioned below:

## 6. Documents required at the time of Walk-In:

### (a) For Verification of Original Certificates:

1. Aadhar Card
2. SSC/10<sup>th</sup> Marks Certificate.
3. Birth certificate (*in case date of birth is not mentioned in SSC Certificate*)
4. Degree/ Diploma Certificate marks sheets (*all semesters or consolidated mark sheet*)
5. Original/ Provisional Certificate of qualifying Degree/ Diploma.
6. Reservation/ Community/ Caste certificate (SC, ST, OBC, EWS, XSM, PWD/ PH) if applicable.

### (b) Documents for Submission.

1. One set of Photo copy/Xerox copy of all the above Certificates.
2. Passport size photographs.



**7. Important Instructions:**

- a. Selection is based only on CGPA/ Percentage of marks secured in Diploma/ Engineering Degree/Graduation in general stream. There will be no written test or interview.
- b. Before appearing for the walk-in to apply for Apprenticeship, the candidates should ensure that they meet the requisite eligibility criteria. Candidates should also ensure that the particulars furnished by him/ her in the application are true/ correct in all aspects. In case of submission of any false/ incorrect information or suppression of any facts by any of the candidates or any discrepancy found during the entire engagement process/ training period, the candidature of the respective Candidate shall be cancelled/ terminated with immediate effect.
- c. Candidates who have passed the qualifying examination and possessing Original/ Provisional certificate are only eligible.
- d. Candidates who have already joined/ pursuing/ about to join any regular courses for higher education during the stipulated Training Period need not apply.
- e. Merit list of the provisionally shortlisted candidates shall be hosted on "www.hal-india.co.in" on **30<sup>th</sup> June 2026** and confirmation emails shall be forwarded to the shortlisted candidates subsequently.
- f. The **date of joining/ reporting** for the Apprenticeship is **27<sup>th</sup> July 2026**. All the provisionally shortlisted candidates should be in a position to join the establishment by the prescribed date of joining. If the candidate does not report latest by scheduled date, it is assumed that he/ she is not interested in the apprenticeship and his/ her candidature will be forfeited.
- g. Candidates those who have undergone Apprenticeship Training or who are undergoing similar apprenticeship training/ or registered for Apprenticeship training in the respective Qualification under the Apprentices Act 1961 elsewhere are not eligible.
- h. OBC candidates should produce Valid Non-Creamy Layer certificate.
- i. Canvassing in any form shall lead to disqualification of the candidature.
- j. HAL reserves right to alter the allocation of quota for trades any time during the process of engagement. Also, HAL reserves the right to cancel the advertisement and/ or the selection process there under. Decision of HAL Management regarding the selection will be final. Further HAL Management reserves the full right to fill up or otherwise any or all the notified posts depending on the availability of the candidates in any trade/ discipline and also to fill up the vacancies if any.
- k. The candidate has to make his/ her own arrangement for accommodation & travelling for the Walk-in process/ joining the apprenticeship.
