## **II. MINIMUM EDUCATIONAL QUALIFICATIONS:**

## A. Category – I Technician (Diploma) Apprentices:-

- A Diploma in Engineering or technology (Full time) granted by a State Council or Board of Technical Education established by a State Government in relevant discipline.
- A Diploma in Engineering or Technology(Full time) granted by a University in relevant discipline.
- A Diploma in Engineering and Technology granted by an Institution recognised by the State Government or Central Government as equivalent to above.

### B. <u>Category – II Non-Engineering Graduate Apprentices:-</u>

 A Degree in Arts/ Science/ Commerce/ Humanities such as BA/ B.Sc., / B.Com/ BBA/ BBM/ BCA etc., (Regular – Full time) granted by a Statutory University / Deemed University in relevant discipline. – UGC approved

#### III. AGE:

Age limit will be followed as per Apprenticeship Rules.

#### IV. RESERVATION OF VACANCIES:

Guidelines under Apprentices Act on Reservation for SC/ST/OBC/PwD will be followed. Those who are claiming reservation under SC/ST/OBC/PwD shall provide certificate as per Government standard format, failed which their claim for reservation will be considered as 'General' category only. If BC/MBC candidates claiming OBC (Noncreamy layer) category, they should bring OBC(NCL) certificate as per the approved (OBC (NCL)) format from the certificate issuing authority.
